

Future Scholars Learning Center is a child care and learning center that opened its doors for business on June 4, 2012 in Biloxi, Mississippi. The Center currently has 7 full time employees, all having CPR and First Aid certification. The employees and the owner, Christine Radich, utilize their strong background in early childhood development and education by offering a specialized education curriculum based learning program for their students.

The Center takes infants and children up to 5 years of age. Future Scholars Learning Center also offers child care services on the 1st and 3rd Saturday of the month from 4pm to 10pm. The Saturday services are open to the public. The Center has been very successful in its first 2 months of operation, running at full capacity (42 children) and having an additional 10 spots reserved on
