

Did you know, the MSBDC offers export training and counseling for those Mississippi small businesses and entrepreneurs who are interested in growing their business in overseas markets? The organization has three centers with counselors who have completed the SBA Export and Certification program. Located in three regional areas (North MS, Hinds County area, and the Gulf Coast), they offer one-on one counseling and training for small businesses who are interested in increasing sales and profits through exporting. Some of the questions commonly answered by these counselors would include:

Do I have an exportable product?
How much inventory will be required to sell overseas?
How do I go to market?
(And most important)How will I get paid?

Training seminars offered throughout the state are designed to cover basics, such as, finding export data available through government agencies, computer links to lenders who specialize in export lending and specialist in the field of freight logistics. One-on-one counseling is also offered to individuals who require specific markets and customers identified.
